TMCMS ANNUAL MEMBERSHIP DINNER AND MEETING



WSMA LEGISLATIVE SUMMIT UPDATE

The annual WSMA Legislative Summit was on January 26. Several members of the TMCMS attended this event. The event began with a full morning of presentations from policy-makers in Olympia. There was a panel discussion with three board members from the Exchange Board, a state agency panel which included Mike Kreidler, the Insurance Commissioner, John Wiesman, the Secretary of the Department of Health and a representative from the Department of Social and Health Services. That panel was followed by a presentation from Melanie de Leon, the Executive Director of the Medical Quality Assurance Commission. And finally, the keynote speaker was Remy Trupin, the Director of the Washington Budget & Policy Center.

Following an informative morning session, attendees went to the Capitol for individual meetings with their legislators. The following is a list of the 2015 WSMA legislative priorities.

- **Reimburse Telemedicine** to ensure access to care in rural and underserved areas.
- Cover Grace Period Claims to prevent uncompensated care.

In partnership with:

Washington WS/MA State Medical Association

- Mental/Behavioral Health Support funding to address psychiatric boarding and mental and behavioral health care needs.
- Student Loan Repayment to encourage medical practice in underserved areas.
- **Graduate Medical Education** to combat physician shortages.
- Fair Medicaid Reimbursement to ensure access to care.

THURSTON COUNTY ORAL HEALTH COALITION

The Oral Health Coalition is a group of dentists, physicians, and social services organizations that meet every other month to discuss topics related to oral health. At the next coalition meeting there will be a discussion on fluoride and dental care in the primary-care physician's office. Dr. Irene Hunter from the Washington Dental Services Foundation will be speaking on the Foundation's Primary Care Physician Training Program and will be available to answer questions from both physicians and dentists.
